Procedure:

1. Combine phase A, add phase B and stir with very high shear for 15 minutes
2. Mix pre-mix phase C and heat phase C and AB to 80°C
3. Add phase C to AB and emulsify
4. Add phase D and stir until homogenous
5. Adjust pH with citric acid to 5,5 and add remaining ingredients of phase E
6. Fill into an appropriate container
