- 1. Combine phase A and heat up to 85°C and stir until homogeneous
- 2. Add phase B and stir until homogeneous
- 3. Add phase C and stir until homogeneous
- 4. Add phase D and stir with medium share until homogeneous
- 5. Pour into an appropriate container

- ⇒ SYNCRYSTAL Very Berry is a veggie and carmin-free pink pearl pigment which provides the berry color.
- ⇒ SYNCRYSTAL Gold provides a warm undertone.
