#### Procedure:

1. Spread CLAYTONE-VP V XR into Isododecane and stir with very high shear for 15 minutes
2. Add Propylene Carbonate while stirring
3. Heat phase A and B separately to 80°C
4. Add phase B to phase A and mix until uniform
5. Cool down to at least 45°C
6. Add one by one phase C and mix until homogenous
7. Fill into an appropriate container

- ⇒ **SYNCRYSTAL Platinum** is responsible for the final metallic brilliance and coverage
- ⇒ **SYNCRYSTAL Red** adds luminosity and warmth to the pink shade
- ⇒ **SYNCRYSTAL Rose Opal** gives the bluish twist, necessary for the berry shade

#### Stability:

Stable for at least 6 months at RT and 40°C.  
Stable for at least 1 month at 50°C.
