Procedure:

1. Spread PURABYK-R 5510 into water and stir with very high shear
2. Add the glycerin of phase B
3. Heat phase AB and C separately to 80°C
4. Add phase C slowly to AB while stirring
5. Cool down to 40°C and add phase D step by step
6. Adjust pH with citric acid to 6-6.5 if necessary
7. Pour into an appropriate container

Stable for at least 6 months at RT and 40°C

Stable for at least 1 month at 50°C
