Procedure

- 1. Melt phase A by heating to 85°C at low to mid shear
- 2. Mix the ingredients of phase B and add to phase A
- 3. Stir with low to medium shear until uniform
- 4. Pour into an appropriate container
- 5. Cool down to RT

- ⇒ SYNCRYSTAL Soft types create a great transparent bronzing appearance, appropriate for many skin tones without mask-like effect of mineral colorants
- ⇒ ECOFIL B110 makes the structure of the effect pigments blur into each other and creates a great silky finish
- ⇒ SYNAFIL S1050 gives the formulation a shinier and brighter appearance
- ⇒ TIXOGEL-CCT ensures a uniform appearance, it prevents sedimentation of the effect pigments during the pouring process into the packaging until it hardens and against deformation until 50°C
