Procedure:

- 1. Heat phase A to 85°C and stir until uniform
- 2. Add the pigments of phase B and mix until homogeneous
- 3. Pour into one place of the wheel and cool down to RT

- 3 Rose: 22% SYNCRYSTAL Red + 2.2% SYNCRYSTAL Sapphire
- + 0.8% SYNCRYSTAL Soft Copper
- 4 Lilac: 22% SYNCRYSTAL Blue
- + 2.2% SYNCRYSTAL Sapphire
- + 0.8% SYNCRYSTAL Soft Copper
- 5 Green: 22% SYNCRYSTAL Green
- + 2.2% SYNCRYSTAL Sapphire + 0.8% SYNCRYSTAL Soft Copper
- 6 Violet: 11% SYNCRYSTAL Red
- + 11% SYNCRYSTAL Blue
- + 2.2% SYNCRYSTAL Sapphire
- + 0.8% SYNCRYSTAL Soft Copper
