### Procedure:

1. Combine phase A and heat to 75°C while stirring
2. Cool down phase A when transparent
3. Add phase B to A and stir with very high shear
4. Premix phase C and add to phase AB while stirring
5. Add phase D to ABC
6. Pour into an appropriate container
